For 2018, there were 77 Complaints filed. Thirty-nine hearings were held. Fifty-seven reductions occurred.

The projected factor provided by Winnebago County for Roscoe Township is 1.0410. This is from a three year average and it helps to give a gradual increase or decrease when applied.

The Winnebago County Supervisor of Assessments listed Roscoe Township as having the best Coefficient of Dispersion (COD). That is the measure of uniformity of assessments for all properties in the township. It measures the average deviation between the selling prices of recently sold properties from the average town-wide level of assessment.
