

**TAX LEVY ORDINANCE**

**TOWNSHIP**

**ORDINANCE No. 2022-1G**

An ordinance levying taxes for all town purposes for Roscoe Township, Winnebago County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Roscoe Township, Winnebago County, Illinois, as follows:

SECTION 1: That the sum of Seven Hundred Forty-nine Thousand and 00/100 Dollars (\$749,000.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township, as required by statute, or voted by the people in accordance with the law, for such purposes as:

GENERAL TOWN FUND  
CEMETERY FUND  
GENERAL ASSISTANCE FUND

for the year 2022.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

**GENERAL TOWN FUND**

Total General Town Fund \$ 708,000

**GENERAL ASSISTANCE FUND**

Total General Assistance Fund \$ 2,000

**CEMETERY FUND**

Total Cemetery Fund \$39,000

**TAX LEVY SUMMARY**

General Corporate Tax	\$708,000
General Assistance Tax	\$2,000
Cemetery Tax	\$39,000

**TOTAL TAXES LEVIED: \$749,000**


SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of Winnebago on or before the last Tuesday of December, a duly certified copy of this ordinance.




