Township of Roscoe County of Winnebago, Illinois

Rules and Regulations of Township Parks and Recreation Areas

Section 1.1 PARK HOURS.

The parks shall be open between the hours of 7:00 a.m. and 10:30 p.m. on every day of the week. The parks may be closed during periods of time as posted (during the winter months).

Section 1.2 PARKING WITHIN THE PARKS

- a. No person shall park or place any vehicle or other property of any kind within the Township Parks so as to obstruct or interfere with traffic or travel or endanger the public safety, and no person shall park any vehicle in any of the following places, except where otherwise designated or except by permit during authorized events:
 - 1. On lawn areas and grounds.
 - 2. In front of public or private drives.
 - 3. In any position to block another car legally parked.
 - 4. At any place where official signs prohibit parking.
- b. Any vehicle parked or standing within the parks in violation of any law, ordinance, or rule is declared a public nuisance. Such vehicle may be removed and impounded, and the owner or person entitled to possession of the vehicle shall pay all charges and expenses arising out of any action taken hereunder.

Section 1.3 MOTORIZED VEHICLES WITHIN THE PARKS

No person shall haul, drag, ride, or drive any automobile, truck, motorcycle or other vehicle within the Township Parks except:

- 1. Upon the parking lots, roadways and other areas provided for driving or parking the same.
- 2. Township employees in the performance of their duties.
- 3. Other areas by permit during authorized events.

Section 1.4 SPEED OF VEHICLES

No person shall drive any vehicle within the Township Parks at a speed greater than fifteen (15) miles per hour, or greater than is reasonable and proper with regards to traffic conditions and the use of the roadway, or at a speed that endangers the safety of any person or property.

Section 1.5 NARCOTIC DRUGS

- a. No person within or entering any park shall use, consume, smoke, or be under the influence of any drug or narcotic designed to induce excitement, exhilaration, hallucination, drowsiness, or any other abnormal or unusual conduct or behavior upon the part of the recipient or user thereof.
- b. This section shall not apply to any drug taken or used pursuant to a doctor's prescription, nor to any nonprescription drug designed to reduce or cure human illness, pain or suffering.

Section 1.6 INTOXICATING LIQUORS

No person shall consume or possess any intoxicating liquor within any Township Parks unless authorized through a valid permit. A permit may be obtained from the Township Clerk for the consumption of beer and wine only.

Section 1.7 INTOXICATED AND DISORDERLY PERSONS

No persons, while in a state of intoxication, shall enter, lounge, wander about, or remain in the Township Parks. No person shall create any disturbance or disorderly conduct in the Township Parks.

Section 1.8 OBSCENE LANGUAGE, AND VIOLENT OR OBSCENE CONDUCT

No person shall use any vile, abusive, profane, indecent, or obscene language or engage in any vile, abusive, violent, indecent, or abusive conduct within the Township Parks which might reasonably result in a breach of the peace or interfere with the peaceable enjoyment of park facilities by others.

Section 1.9 INJURY TO TREES, SHRUBS, STRUCTURES, AND PROPERTIES

No person shall cut, break or in any way injure or deface any tree, shrub, plant, flower, turf, or any of the buildings or other structures and properties, or dig into the soil or into any road, park, parkway, or playground, within the Township Parks without permission of the Township Supervisor to do so.

Section 1.10 TRESPASSING

No person shall trespass, stand, walk, ride, or write upon any place laid out and appropriated for shrubbery or grass when there shall have been placed thereon a sign forbidding same.

Section 1.11 DOGS, CATS AND OTHER ANIMALS

a. No person shall ride, drive, or lead any animal, except dogs or cats, over or through any Township Parks.

b. No person shall bring a dog or cat within the Township Parks unless such animal is properly leased and under control at all times.

Section 1.12 HUNTING, TRAPPING, KILLING BIRDS AND ANIMALS

No person shall hunt, trap, catch, wound, kill or treat cruelly or attempt to hunt, trap, catch, wound, or kill any bird or animal in the Township Parks.

Section 1.13 FIRES

No person shall light or make use of any fire in the Township Parks, except at such places as may be established for such purposes and then only under such rules as may be prescribed therefore. Every fire shall be continuously under the care and direction of a competent person from the time it is kindled until it is completely extinguished.

Section 1.14 REFUSE, GARBAGE DEPOSITS; LITTERING

No person shall deposit or leave any garbage, refuse, or other materials of any kind on the park grounds or waters. Paper, glass, cans, garbage, and other refuse of every kind shall be deposited in receptacles provided for that purpose, and no person shall litter or suffer or cause the Township Parks to be littered in any way.

Section 1.15 RESTRICTED AREAS, BUILDING AND PARK USES

- a. No person shall enter upon any portion of the Township Parks where persons are prohibited, as indicated by signs or notice. No person shall enter or attempt to enter any building or area in the parks when it is closed to the public.
- b. No person shall be permitted to utilize areas of the park reserved for specific groups and events including those with specific permits or agreements with the Township unless invited by same. During these specified times and events, these organizations or persons with permits or agreements shall have exclusive use of the specified areas.

Section 1.16 PERMITS FOR SPECIAL PARK USES

- a. Anyone desiring to reserve areas of the Park for specific events and times may do so by obtaining a permit from the Township Clerk upon payment of a \$10.00 fee. No permit may be issued which is in conflict with prior agreements struck for the use of the Township Parks. Any prior agreements shall take precedence over permits issued.
- b. Anyone desiring to consume beer or wine for a specific event or period of time may do so by obtaining a permit from the Township Clerk. No permit may be issued which is in conflict with prior agreements struck for the use of the Township Parks. Any prior agreement shall take precedence over permits issued.

Section 1.17 PENALTIES

Any person violating any of the provisions of this Ordinance shall be fined not less than Five Dollars (\$5.00) nor more than Fifty Dollars (\$50.00) for each offense.

1.18 – USE OF CERTAIN DEVICES OR EQUIPMENT.

a. No person shall use any slingshot, javelin, shotput, discus, golf equipment, or archery equipment, or any device capable of launching a projectile, in or upon any Township Park or Recreation Area, except in areas specifically designated or provided for that particular use."



No person shall drive any vehicle within the Township Parks at a speed greater than fifteen (15) miles per hour, or greater than is reasonable and proper with regards to traffic conditions and the use of the roadway, or at a speed that endangers the safety of any person or property.

Section 1.5 NARCOTIC DRUGS

- a. No person within or entering any park shall use, consume, smoke, or be under the influence of any drug or narcotic designed to induce excitement, exhilaration, hallucination, drowsiness, or any other abnormal or unusual conduct or behavior upon the part of the recipient or user thereof.
- b. This section shall not apply to any drug taken or used pursuant to a doctor's prescription, nor to any nonprescription drug designed to reduce or cure human illness, pain or suffering.

Section 1.6 INTOXICATING LIQUORS

No person shall consume or possess any intoxicating liquor within any Township Parks unless authorized through a valid permit. A permit may be obtained from the Township Clerk for the consumption of beer and wine only.

Section 1.7 INTOXICATED AND DISORDERLY PERSONS

No persons, while in a state of intoxication, shall enter, lounge, wander about, or remain in the Township Parks. No person shall create any disturbance or disorderly conduct in the Township Parks.

Section 1.8 OBSCENE LANGUAGE, AND VIOLENT OR OBSCENE CONDUCT

No person shall use any vile, abusive, profane, indecent, or obscene language or engage in any vile, abusive, violent, indecent, or abusive conduct within the Township

Parks which might reasonably result in a breach of the peace or interefere with the peaceable enjoyment of park facilities by others.

Section 1.9 INJURY TO TREES, SHRUBS, STRUCTURES, AND PROPERTIES

No person shall cut, break or in any way injure or deface any tree, shrub, plant, flower, turf, or any of the buildings or other structures and properties, or dig into the soil or into any road, park, parkway, or playground, within the Township Parks without permission of the Township Supevisor to do so.

Section 1.10 TRESPASSING

No person shall trespass, stand, walk, ride, or write upon any place laid out and appropriated for shrubbery or grass when there shall have been placed thereon a sign forbidding same.

Section 1.11 DOGS, CATS AND OTHER ANIMALS

Section 1.13 FIRES

No person shall light or make use of any fire in the Township Parks, except at such places as may be established for such purposes and then only under such rules as may be prescribed therefore. Every fire shall be continuously under the care and direction of a competent person from the time it is kindled until it is completely extinguished.

Section 1.14 REFUSE, GARBAGE DEPOSITS; LITTERING

No person shall deposit or leave any garbage, refuse, or other materials of any kind on the park grounds or waters. Paper, glass, cans, garbage, and other refuse of every kind shall be deposited in receptacles provided for that purpose, and no person shall litter or suffer or cause the Township Parks to be littered in any way.

Section 1.15 RESTRICTED AREAS, BUILDING AND PARK USES

- a. No person shall enter upon any portion of the Township Parks where persons are prohibited, as indicated by signs or notice. No person shall enter or attempt to enter any building or area in the parks when it is closed to the public.
- b. No person shall be permitted to utilize areas of the park reserved for specific groups and events including those with specific permits or agreements with the Township unless invited by same. During these specified times and events, these organizations or persons with permits or agreements shall have exclusive use of the specified areas.

Section 1.16 PERMITS FOR SPECIAL PARK USES

- a. Anyone desiring to reserve areas of the Park for specific events and times may do so by obtaining a permit from the Township Clerk upon payment of a \$10.00 fee. No permit may be issued which is in conflict with prior agreements struck for the use of the Township Parks. Any prior agreements shall take precedence over permits issued.
- b. Anyone desiring to consume beer or wine for a specific event or period of time may do so by obtaining a permit from the Township Clerk. No permit may be issued which is in conflict with prior agreements struck for the use of the Township Parks. Any prior agreement shall take precedence over permits issued.

Section 1.17 PENALTIES

Any person violating any of the provisions of this Ordinance shall be fined not less than Five Dollars (\$5.00) nor more than fifty Dollars (\$50.00) for each offense.

AN ORDINANCE AMENDING THE USES OF PARKS AND RECREATION AREAS WITHIN ROSCOE TOWNSHIP

WHEREAS, pursuant to the statutes and laws of the State of Illinois, the Township of Roscoe has set aside certain lands to be used for parks and recreation areas for the free use of the Public; and

WHEREAS, the Township Board of Trustees have previously set forth certain rules and regulations for the use and conduct in Township parks and recreation areas, specifically those rules and regulations set forth in Ordinance 1991-1; and

WHEREAS, the to protect the quality of the park and recreation areas, and the safety of the users therein, the Township Board wishes to restrict the hitting of golf balls within such areas; and

WHEREAS, it is in the best interests of Roscoe Township to amend such rules and regulations as set forth herein; and

WHEREAS, Roscoe Township is authorized by statute to take the action outlined in this Ordinance; and

NOW THEREFORE, be it ordained by the Board of Trustees of Roscoe Township, Winnebago County, Illinois, as follows:

Section 1. The foregoing recitals are incorporated herein as findings of the Township of Roscoe Board of Trustees.

Section 2. The parks and recreation areas Rules and Regulations as setforth in Ordinance 1991-1 are hereby amended to add the following section:

" §1.18 – Use of Certain Devices or Equipment.

A. No person shall use any slingshot, javelin, shotput, discus, golf equipment, or archery equipment, or any device capable of launching a projectile, in or upon any Township Park or Recreation Area, except in areas specifically designated or provided for that particular use."

Section 3. That this Ordinance shall be in full force and effect from and after its adoption as provided by law.
