An ordinance levying taxes for all road purposes for Roscoe Township Road District, Winnebago County, Illinois, for the tax year 2021 collectable in 2022.

BE IT ORDAINED by the Board of Trustees of Roscoe Township, Winnebago County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Roscoe Township Road District on November 10th, 2021 does hereby determine and declare that the sum of Eight Hundred Ten Thousand and 00/100 Dollars (\$810,000.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

ROAD and BRIDGE
PERMANENT ROAD (HARD ROAD)
BRIDGE CONSTRUCTION W/COUNTY (SPECIAL BRIDGE)

For the year 2021.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

GENERAL ROAD FUND

Total General Road fund \$ 81,880.00

PERMANENT ROAD (HARD ROAD) FUND

Total Permanent Road Fund \$720,800.00


BRIDGE CONSTRUCTION (SPECIAL BRIDGE) FUND

Total Bridge Construction \$ 7,320.00


SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Roscoe Township Road District.


