**TAX LEVY ORDINANCE
TOWNSHIP
ORDINANCE No. 2024-1G**

An ordinance levying taxes for all town purposes for Roscoe Township, Winnebago County, Illinois, for the tax year 2024, collectable in 2025.

BE IT ORDAINED by the Board of Trustees of Roscoe Township, Winnebago County, Illinois, as follows:

SECTION 1: That the sum of Six Hundred Fifty Thousand and 00/100 Dollars (\$650,000.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township, as required by statute, or voted by the people in accordance with the law, for such purposes as:

- GENERAL TOWN FUND
- CEMETERY FUND
- GENERAL ASSISTANCE FUND

For the year 2024.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

GENERAL TOWN FUND

Total General Town Fund \$609,000.00

GENERAL ASSISTANCE FUND

Total General Assistance Fund \$ 2,000.00

CEMETERY FUND

Total Cemetery Fund \$ 39,000.00


SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of Winnebago on or before the last Tuesday of December, a duly certified copy of this ordinance.


SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.




