

**TAX LEVY ORDINANCE**

**ROSCOE TOWNSHIP ROAD DISTRICT**

**ORDINANCE 2025-1R**

An ordinance levying taxes for all road purposes for Roscoe Township Road District, Winnebago County, Illinois, for the tax year 2025, collectable in 2026.

BE IT ORDAINED by the Board of Trustees of Roscoe Township, Winnebago County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of the Roscoe Township Road District on December 18, 2025, does hereby determine and declare that the sum of Eight Hundred Eighty-Four Thousand Seventy-Four and 00/100 Dollars (\$884,074.00) is hereby levied upon all property subject to taxation within the Roscoe Township Road District as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Roscoe Township Road District, as required by statute, or voted by the people in accordance with the law, for such purposes as

ROAD AND BRIDGE FUND  
PERMANENT ROAD (HARD ROAD) FUND  
BRIDGE CONSTRUCTION W/COUNTY (SPECIAL BRIDGE) FUND

For the year 2025

SECTION 2: That the amount levied for each object and purpose shall be as follows:

GENERAL ROAD FUND

Total General Road Fund \$ 89,330.00

PERMANENT ROAD (HARD ROAD) FUND

Total Permanent Road Fund \$786,754.00

GENERAL ASSISTANCE FUND

Total Bridge Construction Fund \$ 7,990.00






