An ordinance levying taxes for all town purposes for Roscoe Township, Winnebago County, Illinois, for the tax year 2025, collectable in 2026.

BE IT ORDAINED by the Board of Trustees of Roscoe Township, Winnebago County, Illinois, as follows:

SECTION 1: That the sum of Six Hundred Eighty-Three Thousand Eight Hundred Forty-Three and 00/100 Dollars (\$683,843.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all necessary expenses and liabilities of the Township, as required by statute, or voted by the people in accordance with the law, for such purposes as

GENERAL TOWN FUND
CEMETERY FUND
GENERAL ASSISTANCE FUND

For the year 2025

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 5: That this Ordinance shall be in full force and effect after its adoption, as provided by law.

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of Roscoe Township and the Roscoe Township Road District, Winnebago County, Illinois, and as such presiding officer, I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-90 of the Truth in Taxation Act.

Check one of the following:

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Act.
- 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- 3) The proposed aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The adopted tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the Truth in Taxation Act.
- 4) The adopted levy exceed the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Act.
